From the Pastor's Desk

Pastor Dick Hotchkin

In the past, Sunday was set aside. Work was minimal. An aura of reverence pervaded the day. People did not pray all day long, but God hovered over Sunday, giving human beings rest from the tedium of the week.

Our complex modern society has robbed us of the blessing of Sunday. Not altogether, however. There is respite from routine. There are visits to friends and family. There is recreation. Leisure and play, healing as they are, may in themselves become destructive. We may have to return from an exhausting weekend to find rest in routine again. And what is worse, the preoccupation with recreation may distract us from any thought of God.

One historian has said that the old Germany was destroyed by Hitler when he initiated his Sunday programs for youth, taking them away from the churches. Disobedience to the commandment, "Remember the Sabbath day, to keep it holy," changed the character of that nation. If God's day can be wiped out, God can be forgotten.

It will take individual and personal disciplines for us to recover Sunday. It may be quite futile to roll back to the day when stores were closed, whole communities finding their way to churches, traffic on the highways at a minimum. The best we can do is to resist the tempo by self-discipline. Most important, certainly for people who profess faith in God, is to find our way to church.

A Pastor writes, "In one of my churches was a man who had not missed a Sunday service in 32 years. Why this self-imposed discipline? Certainly not because church services were always so edifying. And not because he feared that God would punish him for any lapse. The reason was quite clear: he had resolved that he ought to set aside at least an hour a week to thank God in company with others who gathered to thank God."

When someone says, "I feel better when I've been to church," don't dismiss her as a romantic or a fanatic. She may very well be on to something profoundly great!

Vernie is a 62-year member of First Congregational UCC Alpena. She and her husband Gordon joined the church in 1962 when they moved to Alpena from the Detroit area. Through the years, Vernie has been very involved in the church by holding a variety of positions on boards and committees, and singing in the

choir. She and Gordon raised their children, Cynthia, John, and Bill, in Alpena; and they were very involved in the church as a family as well.

Some favorites memories of Vernie's church involvement were family events and Pilgrim Fellowship retreats she participated in when she served as a PF sponsor. She has fond memories of Rev. Jack Fitzgerald. The Nethercut family was grateful that he was able to travel to perform their son John's wedding in Pennsylvania, and daughter Cynthia's wedding in New Jersey. Vernie also has dear memories of Rev. Dr. Bob Case during his leadership at our church, and for the memorial service he performed for her husband Gordon in 2021.

Vernie commented that, since 1962, the church has impacted her life through meaningful pastoral guidance, Bible discussions, and while working on church boards and committees. She appreciates the pastoral support and counsel she received through the years, especially coaching the church Moderators, the implementation of Ministry Teams and as she served as coordinator, and as the interdenominational college group sponsor.

EARLIEST CEMETERIES

The earliest known burying ground in this area was on the banks of the Thunder Bay River where the present post office is located. This was an Indian burial ground.

Sometime after the Carter Family arrived in what was to become Alpena in 1856, a burial site for those who died was established way out in an area called the Plains—then a long way from the few residences. It was in the now 11th Street area where the recent Thunder Bay Manufacturing Company was located.

At a meeting at the First Congregational Church on March 3, 1862, a motion was made and supported and carried that the Society instruct the trustees of the church to take measures to procure title to the burial grounds, or cemetery grounds, "the same that has been used for that purpose near the village." The site served as the village cemetery until 1873.

...The remains from those interred in the burial grounds near what is now 11th street were disinterred and re-buried in the newly named Evergreen Cemetery.

Recollections and memories throughout the years....

Mr. and Mrs. (David) Plough were leading members of the Congregational Church...he being one of the church officers and Mrs. Plough one of the charter members....After much searching, we find that Mrs. Plough's death occurred on December 10, 1888. The following two brief announcements of her death and burial were in the Alpena Argus – 1888 *"Mrs. David Plough, formerly of this city, died at Sand Beach Monday. The remains will be brought to this city for burial. Funeral from Congregational Church tomorrow at 2 o'clock."*

And..."The funeral of Mrs. David Plough took place last Thursday, the service being held at the Congregational Church. Mrs. Plough was one of the pioneers of this county. She was one of the charter members (or founders) of the Congregational Church. The floral arrangements were superb."



Jim Park

Jim Park was born in Alpena and baptized at First Congregational Church in 1937. He officially joined the church at age 13 and has been a lifetime member for 74 years. He along with Joan Chrzan and Dixie Julian hold the longest memberships. Jim continued his membership while in College and also while work-



ing with Price Waterhouse, first in Venezuela (1982-1986), Washington DC, and Tampa. Jim joined the Besser Company in 1980 and continues membership while in Alpena and also while wintering in Florida.

Jim states that "one of my favorite memories was singing carols as the choir walked from the old church to the new church that was built with concrete masonry with the financing of Jesse and Anna Besser in 1955."

Jim has enjoyed all the Ministers over the years and remember when Phil Park sent the Besser airplane to facilitate the interview with Rev. Barksdale, and subsequently enjoyed hearing his southern drawl while preaching his sermons. Jim enjoyed playing softball on the famous Whippets team with Rev. Robert Case who was the pitcher and long ball hitter. He also thinks fondly of Rev. Paul Lance who came back to his hometown to serve as our minister.

We appreciate Jim for his long years of membership and thank him for his continued support of our church.
